#### 1. Access and Use of the Service

Also your consent to receiving emails from the Service to facilitate optimal use, including password reset links and an annual reminder to complete the VEGANScreener) is required before the use of this Service. # 3. Data Use & Data Storage

Your data for use in the web app is stored separately from data used for scientific research. Specifically:

- **Register A** stores data necessary for the operation and improvement of the web app, this includes account information, *Basic Survey* responses and *VEGAN SCREENER Survey* responses. Your consent to the storage and use of your data in Register A is required before the use of this Service.
- **Register B** stores data for scientific research purposes in connection with the Center for Public Health. Your data will only be copied to Register B if you explicitly consent to this, either during registration or later via your account settings. Each change made in the Account Settings will immediately be updated in Register B. If you consent, your *Basic Survey* data and *VEGAN SCREENER Survey* data will be stored in Register B in a pseudonymized form, meaning it will only include your responses and exclude any personally identifiable information (such as email addresses, passwords).
- If you consent to the use of your email address for contact purposes, it will be stored separately in **Register C**. Register C will only contain your email address, with no connection to any other data.

# 4. Account Deletion and withdrawal of your consent

If you delete your account, all data stored for the operation of the web app (Register A), including your email address and password, will be deleted.

If you have previously consented to the use of your data for scientific research, your data in Register B may still be used in accordance with that consent. If you no longer want your survey data to be used, you must revoke your consent in the account settings before deleting your account. You can also with-draw your consent by sending us an email (please refer to the privacy policy for more information).

If you have previously consented to the use of your email address for contact purposes, your email address in Register C may still be used in accordance with that consent. If you no longer want your email address to be used for contact purposes, you need to revoke this consent in the account settings before

deleting your account. You can also withdraw your consent by sending us an email (please refer to the privacy policy for more information).
